TERMS & CONDITIONS

By sending this form, I confirm that I have read the following terms and conditions of the CONTEMPORARY DESIGN MARKET. I fully accept them without any reservation, and I will commit myself to confide in them.

CONTEMPORARY DESIGN MARKET (from 28/09 to 29/09/2019) organised by Design September ASBL (herein after The ORGANIZER).

- 1. ADMISSION** Anyone wishing to participate in the fair must obtain and submit an application form to the organizer. The organizer reserves the right to accept or refuse any request to participate at the CONTEMPORARY DESIGN MARKET.
- 2. PAYMENT** A deposit of 50% will be requested upon booking, and full payment must be made by the 15/08/2019. The reserved space will only be made available to the exhibitor after payment of all sums due. In case of cancellation of participation 2 months before the exhibition and/or event, the registration fee and the 50% deposit will remain due.
- 3. STAND RESERVATION** Stands are allocated on a first-come, first-served basis, subject to availability.
- 4. PRODUCTS AND SERVICES** Exhibitors are expected to have the necessary documentation of the products and services displayed on their stand. Therefore, the organizer assumes no responsibility for this.
- 5. BANNED PRODUCTS** No toxic, explosive or of similar danger products may be introduced into the CONTEMPORARY DESIGN MARKET. The organizer reserves the right to request the immediate withdrawal of any product.
- 6. DEVELOPMENT** The organizer reserves the right to refuse any material and / or furniture whose condition and / or presentation would devalue the appearance of the CONTEMPORARY DESIGN MARKET.
- 7. DISMANTLING** The dismantling will start on Sunday evening, from 5PM. Unless authorized by the organizer, no one may dismantle, even partially, his/her stand before time and day indicated in the booking confirmation.
- 8. RESPONSIBILITIES AND INSURANCE** The organizer declines any responsibility, concerning any fault or damage caused by a member of the staff of the organizing company, as well as any damage or theft which could occur to the exhibited material.
